




PROFESSIONAL PROSPECTS

ACADEMIC PROGRAMMES

B.A. LL.B. (Hons.) (Five-Year Integrated Law Degree Programme)

The **B.A. LL.B. (Hons.)** programme at **JRSET College of Law**, affiliated with the University of Kalyani, is a five-year integrated undergraduate course in law. This programme encompasses a comprehensive curriculum that integrates Arts and Law subjects, providing students with a strong foundation in both disciplines. The curriculum includes subjects such as Political Science, Sociology, and Economics, along with core law courses, clinical law papers, and elective subjects like Media Law, Intellectual Property Rights, and Cyber Law, as prescribed by the Bar Council of India (BCI). Additionally, honours subjects such as Interpretation of Statutes, Land Law (including Tenure and Tenancy System), and Human Rights Law and Practice are offered in accordance with BCI regulations.

LL.B. (Three-Year Law Degree Programme)

The **LL.B. (Three-Year Degree Programme)** at JRSET College of Law, affiliated with the University of Kalyani, is designed for graduates seeking a comprehensive legal education. The curriculum includes core law courses, clinical law papers, and elective subjects such as Media Law, Intellectual Property Rights, and Cyber Law, in compliance with BCI regulations.

MOOT COURT

The Moot Court Hall at **JRSET College of Law** is designed to provide students with practical exposure to courtroom proceedings. A dedicated Moot Court Committee, comprising student representatives and faculty coordinators, oversees moot court activities, workshops, and seminars to enhance advocacy and research skills. Regular intra-departmental moot court competitions are conducted, offering students hands-on experience in legal argumentation. Additionally, renowned advocates are invited to train students in pleading and advocacy.

Eligibility for Admission

Eligibility for B.A.LL.B (Hons) :-

1. Passed the HS (10+2) or an equivalent examination with 45% marks (general) and 40% marks for SC/ST of the total marks.
2. Not completed 20 years of age on the 1st day of July of every year. In case of candidates belongs to SC/ST categories a relaxation of two year in age should be admissible and deserving cases upper age limit may be relaxed by the college authority.

Eligibility for LL.B :-

1. Graduated in any discipline of knowledge from a University Established.
2. Not below 45% in general category, Not below 42% OBC,
Not below 40% of the total marks in cast of SC, ST applicant.

Number of Seats and Reservation :-

The total number of seats for B.A. LL.B (Hons) degree programme shall be sixty. The admission of the SC/ST candidates will be as per rules.

Prospectus and Application Forms :-

Prospectus and application Form will be available from the office on payment of Rs. 350/- in cash or by the Demand Draft drawn in favor of JRSET College of Law in any nationalised bank payable at Chakdaha.

Sports facility :-

The college has a big play ground with outdoor and indoor sports equipments.

Attendance :-

A student will not be allowed to give their semester examination unless he or she has secured not less than 70% of the attendance in the class and has completed all assignments project works. However, in exceptional cases for cause shown to the college authorities and with prior permission a student who fails to secure the minimum required attendance may be permitted to give the end semester examination. The student should wear the prescribed uniform of the college during the sessions, examinations and during and after academic activities with in the college campus and during all programmes of the college.
